On March 17, 2016

School Resource Officer Heidi Thomas initiated an investigation regarding suspicious circumstances between a 14 year old male juvenile from Gerber and 21 year old Thomas Seagraves of Red Bluff. After a lengthy investigation, which included the review of over 26,000 text messages during an 8 month period, Officers from the Red Bluff Police Department obtained 8 search warrants from the Tehama County Superior Court which included four residences, three in Tehama County and one in Butte County, AT&T Cellular, Sprint Cellular, Verizon Cellular and Facebook.

On April 19, 2016 at about 7:00 A.M., Officers from the Red Bluff Police Department, the Tehama County District Attorney Bureau of Investigations and the Tehama County Sheriff's Office served search warrants in the City of Red Bluff, Tehama County and Butte County. During the service of those search warrants, numerous items were seized as evidence and the following subjects were arrested and charged with the listed crimes;

- 21 year old Thomas Seagraves of Red Bluff
 1. 266j PC - Procurement of minor for sex acts
 2. 288a(b)(1) PC - Oral copulation with a minor
 3. 286(b)(1) PC - Sodomy with a minorSeagraves was booked into the Tehama County Jail and bail was set at \$130,000.
- 20 year old Michael Flowerdew of Red Bluff
 1. 288.3(a) PC - Contact minor with intent of sex act
 2. 288a(b)(1) PC - Oral copulation with minor
 3. 289(h) PC - Penetration with foreign object with minorFlowerdew was booked into the Tehama County jail and bail was set at \$155,000.
- 19 year old Bryan Morrison of Red Bluff
 1. 288.3(a) PC - Contact minor with intent of sex act
 2. 288a(b)(1) PC - Oral copulation with minor
 3. 286(b)(1) PC - Sodomy with a minorMorrison was booked into the Tehama County Jail and bail was set at \$215,000.
- 19 year old Alexander Isaacson of Gridley
 1. 288.3(a) PC - Contact minor with intent of sex act
 2. 288a(b)(1) PC - Oral copulation with minor
 3. 286(b)(1) PC - Sodomy with a minorIsaacson was booked into the Butte County Jail and bail was set at \$115,000.

This case remains under investigation.
